## What is this product?

### **Type**

This product is an investment fund.

## **Objectives**

**Investment objective** The investment objective of the Sub-Fund is to provide investors with an adequate exposure to the corporate bond Euro market.

**Investment policies** The Sub-Fund will mainly invest in government and corporate bonds according to the principle of risk diversification. Such bonds may be denominated in any currency, issued by borrowers headquartered in any OECD country and primarily shall have received a minimum rating of BBB-(minus) by Standard & Poor's or equivalent for the relevant maturity.

The Sub-Fund may also invest in accordance with the terms of the Prospectus, and on an ancillary basis, in other transferable securities, Money Market instruments, derivatives, including but not limited to options, warrants, futures, other equity derivatives traded either on a regulated market or OTC and forward transactions, deposits and units in collective investment schemes.

The Sub-Fund may hold ancillary liquid assets and may invest up to 10% in convertible bonds.

The Sub-Fund may also enter into swap transactions.

The Sub-Fund may invest no more than 10% of its net assets in other UCITS/UCI.

The Sub-Fund will not enter securities financing transactions within the scope of the Regulation (EU) 2015/2365.

Recommendation: this Sub-Fund may not be appropriate for investors who plan to withdraw their money in the short term (2 years).

The Sub-Fund' share class is denominated in EUR.



## Risks

## What happens if Mediobanca Management Company SA. is unable to pay out?
